In accordance with 2016 CA Fire Code Ch. 1 Sec. 105, Ch. 48 Sec. 4811, pursuant to Kern County Ord. 17.32.001 and CCR Title 19

Thank you for choosing Kern County for your filming needs.

As part of the process, you are required to fill out the attached questionnaire and return it to the Fire Department at fireprevention@kerncountyfire.org.

General information related to this process:

- 1) No filming shall take place prior to a review by the fire department.
 - a) If not contacted by phone, you will receive an email when a review has been completed.
- 2) If a FSO standby is deemed necessary a two hour minimum is required plus driving time at \$150/hr. (If there is a cancellation within 48 hrs of standby request a 4 hr deposit could be charged)
- 3) If a catering truck is used, it is required to be equipped with a properly serviced and tagged fire suppression system over any interior gas-fueled cooking equipment.
- 4) A Fire Department Permit will be necessary for any of the following activities:
 - a) The use of pyrotechnic special effects
+ A special effects permit is required through the fire department
 - b) The use of open flames
 - c) The use of flammable or combustible liquids, gases and dust
 - d) Hot work
 - e) Presence of motor vehicles within a building
 - f) Tents and canopies (Tents >400' sq. ft. require a Fire-Department-issued permit)
 - g) Any other hazards as recognized by the Fire Safety Officer
